Re: Vasserman v. Henry Mayo Newhall Memorial

Dear UE Members at Henry Mayo Newhall:

Please allow this letter to serve as a status in the current proposed class action lawsuit pending in Los Angeles Superior Court against Henry Mayo Newhall Memorial Hospital. This lawsuit was filed by a former RN, Tanya Vasserman, and she is seeking to represent herself and other similarly situated hourly nonexempt employees who worked at Henry Mayo Newhall Hospital at any time from June 8, 2010 to the present. This is a wage and hour proposed class action lawsuit as well as a Private Attorney General lawsuit. I am writing to inform you of an informational meeting that I am hosting two (2) meetings on Monday October 12, 2015 with my co-counsel Kevin T. Barnes. The purpose of the meetings is to answer any questions you may have about the current lawsuit and what effect the lawsuit may have on you.

We understand that language in your union contract may affect your rights in the current legal action, as well as future court actions. This language is in the collective bargaining agreement between Henry Mayo and United Electrical Radio & Machine Workers of America ("UE") effective February 1, 2014 to January 31, 2017. Under the current collective bargaining agreement, if you are involved in or intend to be part of a current proposed class action lawsuit, you must notify Henry Mayo by "opting out" of the Article 28 (F) arbitration clause within 30 days from the date you become aware or should have become aware of potential claims. (Article 28(G)). We understand that you may have become aware of the Vasserman class action lawsuit recently; accordingly, the opt out period may be running at the present time. As such, time is of the essence. If you would like more information about how this lawsuit and the Article 28 provision and how this may impact you, and how you can exempt yourself from Article 28, please come to one of the October 12 meetings to hear more about this language.

This meeting is intended to be confidential pursuant to your right to privacy since you would be attending to inquire about your legal rights. The meeting is intended to provide information and answer questions that many Newhall UE members have asked. Because this meeting is confidential and intended only for current and former Newhall UE members to be allowed admission, please bring a government-issued I.D. such as a Driver's License, or your current Newhall employee identification badge. The attorneys will be available to answer questions beginning at 4:00 p.m. as set forth below. Food and beverages will be provided. The information for these meetings is:
